("AmeriGas") at a price to the public of \$42.73 (net of underwriting discounts and commissions in the amount of \$1.28 per unit). The AmeriGas Units have been registered under the Securities Act of 1933, as amended, pursuant to a Registration Statement on Form S-3 (File No. 333-186316) of AmeriGas, as supplemented by the Prospectus Supplement dated January 14, 2014 filed by AmeriGas with the Securities and Exchange Commission on January 14, 2014. Heritage ETC, L.P. is the direct owner of the APU common units. ETP owns a 99.999% limited partner interest in Heritage ETC, L.P.; Heritage ETC GP, L.L.C owns a 0.001% general partner interest in Heritage ETC, L.P.; Energy Transfer Partners, L.L.C. owns a 0.8% general partner interest in ETP; Energy Transfer Partners GP, L.P. owns a 0.01% general partner interest GP, L.P.; Energy Transfer Partners, L.L.C. owns a 100% limited liability company interest in Energy Transfer Partners, L.L.C. and a 99.99% limited partner interest in Energy Transfer Partners GP, L.P.; Kelcy L. Warren owns a 81.2% membership interest in LE GP, LLC.
